Students are also seeking skills and knowledge on how to discern reliable information from non-reliable.

Course description: Course examines the causes of obesity, its impact on human health and explores weight loss and diet options for the individual from a holistic perspective, including social, emotional, and physical dimensions of human health. Recommend student have a WR 121 skill level.

Learning outcomes: Demonstrate an understanding of how behavioral, environmental, cultural, and genetic factors influence body weight and obesity. Develop media literacy skills to analyze current diet fads, weight loss trends and treatment for accuracy. design and implement a specific, personalized weight control plan. Demonstrate an understanding of the personal health risks associated with excess body weight and obesity. Demonstrate the ability to find reliable, safe, scientifically sound information regarding methods of weight control.

Reason for new course: This course has been historically (20 some years!) run as a "special projects" class at PCC. The course needs to have a legitimate CCOG!!

Course description: Gain training and experience teaching and leading sixth graders at outdoor school. Requires attending at least one full day training session (10-12 hours) at the outdoor school site prior to the scheduled assignment to work for 1 week, approximately 16 hours per day, 4 days, at a residential outdoor school for 6th graders.

Learning outcomes: On completion of this course the student should be able to:
Independently present and review prepared science lessons to groups of 6th graders. Lead discussions on outdoor science topics. Demonstrate professional behavior in a teaching environment. Work cooperatively with staff and students. Organize and lead 6th graders in everyday cabin living. Demonstrate effective communication skills, particularly speaking, listening and modeling. Use a variety of problem solving skills.
